

# MAKING COMPELLING VISUALS: ENGAGING CLINICIANS WITH MORE THAN WORDS!

## PART 1: OVERALL CONSIDERATIONS

### CHECKLIST OF CONSIDERATIONS FOR DEVELOPING A COMPELLING DETAILING AID

- Appropriate language for audience and appropriate font size
- Colorful
- Key Messages listed clearly with a summary of Key Messages at the end
- Local statistics
- Making the detailing aid available in more than one language
- Ensuring use of reputable sources and tools with clear evidence that supports KMs
- Ensuring the graphics and colors are ADA compliant
- Length of detailing aid based on intended purpose (e.g., using reference guide/manual vs. a quick sheet with a flow chart/algorithms and clinical pearls)
- Use a style manual and consistent branding
- Incorporate clinical guidelines and summaries of studies
- Make information practical
- Use POEMS (Patient Oriented Evidence that Matters)
- Use hyperlinks or QR codes to individual resources and papers
- Make sure your ask is clear
- Compelling images
- Contact information of lead contributor on the materials
- Date and revision number

## PART 2: CONSIDER THE FOLLOWING DETAILING AID CRITIQUES AS PRACTICE

### EXAMPLE 1: FALLS PREVENTION DETAILING AID

#### 1. What do you like about this detailing aid?

- Easy to follow, simple, good font size
- Made for print, but you could still break it down for a PowerPoint
- Colorful
- Key Messages are listed clearly at the beginning before going into more detail
- “Cartoon people” are inclusive
- Facilitates a discussion

- References are included at the end
- Information is easy to find
- Nice “action” graphic under Key Message 1

## 2. What are some opportunities for improvement?

- References could be larger
- Making the orange circle green to match the flow of "good" and "bad"
- Page 3 is too wordy; add more visuals
- Too many pages; limit it to 2 pages
- Add hyperlinks & QR codes
- Add pictures of real people
- Add more information
- Add small icons on page 3 to break up content (e.g., a medicine bottle for medications, a shoe for footwear, etc.)

### 1. What do you like about this detailing aid?

- CEP logo at the top
- Statistics at the beginning
- Symmetry
- Color
- Hyperlinks in table of contents and resources at the end
- Date on the footer of each page
- Content is useful
- Icons in each section

### 2. What are some opportunities for improvement?

- Text is dense; there is a lack of white space and graphics
- Document is too long
- Needs more headers
- Very little use of color after page 1
- Font is too small
- Make a title section and use the ask as your title (e.g., “Falls are Preventable”)
- Use a photo at the beginning to engage the learner
- Include anecdotes from people with lived or living experience
- Add collapsible sections
